

All renewal applicants/students (applicants who have got scholarship during 2017-18) may apply by giving their existing application ID.

All the three Scholarship Schemes are individual beneficiary oriented schemes being implemented by the Ministry of Minority Affairs and the whole scholarship is distributed to the beneficiary under **Direct Benefit Transfer (DBT) mode**.
